



GOP State Representative Rick Womick of Murfreesboro is calling Gov. Bill Haslam a "traitor to the party" over the efforts by a political action committee run by Haslam supporters to defeat opponents of Common Core. Womick takes issue with Haslam trying to do away with opponents in the legislature & the Republican State Executive Committee. The Chattanooga Times Free Press reported that the Advance Tennessee PAC included key Haslam supporters who worked to defeat State Rep. Tony Shipley (R) of Kingsport.

Sen. Bob Corker ranks as the 22nd wealthiest Congressman, with his 2013 worth between \$19.02 million & \$89.7 million based on a Senate Financial Disclosure filed this month. Like Tennessee Congresswoman Diane Black. Corker is annually listed as one of the wealthiest members of Congress. Congressional rules allow lawmakers to list the value of their assets

in broad dollar ranges. Such listings do not include their primary residence or their personal vehicles.

Jim Tracy, who recently lost his race to Congressman Scott DesJarlais by only 38 votes, nevertheless has announced that he will be endorsing DesJarlais for re- election. Stephanie Jarnagin, Tracy Campbell's Campaign Manager, related that Tracy said,' I will always support the GOP Nominee."

TennCare fraud, though committed by a minority, causes consequences affecting every Tennessean. That's because Tennessee taxpayers are left to pay the hospital bills, often running into thousands of dollars. Preventing such fraud has become a top priority for Tennessee officials. The most common reason for fraud is selling prescriptions or forging prescriptions, contributing to 1,395 arrests since 2004. One woman falsely claimed to be pregnant in order to obtain Tenn-Care Benefits.

The Tennessee Department of Health warns of more cases of potentially deadly tick-borne Rocky Mountain Spotted- Fever. As of August 1 there were 1,328 cases reported. Rocky Mountain Sotted-Fever is caused by bacteria transferred from tick bites to humans, which causes a spotted rash. If not treated, the disease is potentially deadly. Initial symptoms include fever, followed by the classic spotted rash. The illness is carried by either the Brown Dog Tick or American Dog Tick which are the most common ticks found in Tennessee.
